



## 247 Time IR35 Trust information

This publication outlines the latest information available for agencies on each trusts management of candidates.

## About 247 Time Payroll

247 Time now operate a weekly payroll on behalf of a number of Trusts. The direct engagement process will remain the same, with the candidates still being paid by the Trust. 247 Time merely process the payment on the Trust's behalf.

247 Time Direct Engagement process applies as normal. All timesheets need to be uploaded by the appropriate deadline for each Trust. All timesheets will then be approved prior to the consolidation for that Trust each week.



Invoices are generated and sent to the Trust for processing. 247 Time will send the Trust information so the Trust can transfer the NET amounts to 247 Time.



Once 247 Time have received the funds from the Trust, they will process payment to the candidates. We anticipate that all candidates will receive payment no later than the Friday following the consolidation, however, we are reliant on the Trust processing the payment to us for us to pay the candidate.
